We are the solicitors for the Plaintiff in the above-noted proceeding. We ask that you bring this letter to the attention of Prothonotary Mireille A. Tabib, who has been appointed as the Case Management Prothonotary for this action.

This letter is further to the Order of Prothonotary Tabib dated September 24, 2010. In that Order, Prothonotary Tabib set out a procedure for the Plaintiff to bring a motion for leave to file the affidavit of Brian Lindblom, sworn August 10, 2010 (the "Lindblom Affidavit").

#### Dear Sirs:

Please bring this e-mail and attachment to the attention of Madame Prothonotary Tabib. Below is a proposed agenda for the case management conference tomorrow.

- 1. Status of the cross-examinations: We believe that all cross-examinations are completed. Cross-examinations of Mr. Tajdin, Mr. Jiwa, Mr, Sachedina and Mr. Bhaloo were completed on the week of August 9, 2010. Cross examination of Mr. Ospreay was completed on August 18, 2010.
- 2. Reply affidavit: Prior to the commencement of the cross-examinations, the Plaintiff served on the Defendants the reply affidavit of his expert Mr. Lindblom. This is attached. Mr. Jiwa has indicated that the Defendants will not be cross-examining on this affidavit. The Plaintiff seeks leave to file it and the Defendants object to this.
- 3. Hearing date: After the filing of the affidavit of Mr. Lindblom, the Plaintiff is ready to have the motion for summary judgment heard. We would like the assistance of the court in scheduling the hearing of this motion. We would, of course, revise our written submissions to reflect any new material which has come out in the cross-examinations and we would be happy for the court to set a time limit for that.
